The Legal Stuff

What Is Covered/Excluded. This Silver Pledge Limited Warranty covers certain GAF roofing products installed on your roof (the "GAF Products") including GAF Shingles, GAF Ridge Cap Shingles, GAF Starter Strip Shingles GAF Leak Barrier products, GAF Roof Deck Protection products. GAF Cobra® Attic Ventilation products, and GAF-labeled Ultimate Pipe Flashing® with EasySleeve (manufactured by Lifetime Tool® & Building Products LLC). This warranty does not cover ShingleMatch™ Roof Accessory Paint, Master Flow® Attic Ventilation, GAF Cornell Nail Base Boof Insulation or low-slope membranes (each of which is covered by a separate limited warranty) or any non-GAF roof products, such as roofing nails. Misapplication of your GAF Products and flashings at valleys, dormers, chimneys, and plumbing vents (the "Covered Flashings") is also covered.

Who Is Covered by This Limited Warranty; Transferability. You are covered by this warranty if you live in the United States or Canada and are the original property owner (i.e., not a builder or installer) or the first subsequent owner if this warranty was properly transferred.

This limited warranty may be transferred only once. The second owner must notify GAF in writing within 60 days after the property transfer has occurred for any cover age to be transferred. (Other than this one transfer, this warranty may not be transferred or assigned, directly or indirectly.) If the transfer takes place during the first 20 years, the second owner shall be entitled to all benefits contained in this warranty. If the transfer takes place afterwards, the length of this warranty shall be reduced to the two-year period after ownership changes. During this two-vear period. GAF's reimbursement to the second owner will be based only on the reasonable cost of replacement GAF Products, reduced by the amount of use that has been received from the GAF Products from date of installation through the date of claim.

How Long Your Warranty Lasts: All GAF Products. 



- . Your roof **MUST** be installed by a GAF Master Elite® Roofing Contractor.
- The roof system must **NOT** be installed over an existing roof—all existing materials must be removed
- If a new nail base insulated deck system is being installed, you must install GAF Cornell Ventilated Nail Base Roof Insulation (covered only by a separate ThermaCal® Nail Base Roof Insulation Panels Ltd. Warranty).
- In addition to eligible GAF Roofing Shingles (see Application Form for eligible products), you MUST use one item from at least four of the following five accessory product categories:

(d) Any COBRA® Attic Exhaust Ventilation product with adequate attic intake ventilation (see Application Form for eligible products). - 7. For maximum weather protection, the use of GAF-labeled Ultimate Pipe Flashing at all plumbing vents is highly recommended (but not required). Ultimate Pipe Flashing will be covered under the Silver Pledge *Limited Warranty* but will not fulfill a required accessory product category.


